Entries close **Wednesday, January 29, 2025 at 7:00 pm**, after which time entries will not be accepted, substitued, cancelled or changed except as provided for in Chapter 1, Sec.16 of the Obedience Regulations. Transfers will be allowed and changes may be made per Sec 16A and 16B of the Obedience Regulations. Transfers and changes must be in writing and presented to the Trial Secretary no later than 30 min prior to start of first class.

All entry changes or cancellations, except those resulting from a judge change, must be made in writing, by mail or email and received by the trial secretary prior to the closing date and time.

Females in Season are not permitted to compete. If a female is withdrawn from competition because it came into season, the Trial Secretary must be notified no later than one half hour prior to the start of the first class in the trial. The club will refund the entry fee, minus a \$10.00 processing fee. The Club will require documentation from the Veterinarian confirming the female to be in season before a refund can be given.

Entry fees will not be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of public enemy or any other cause beyond our control of the organizing committee.
